1) Umupangayi yemereye CMHA gukurako amahera kw, ikonte yo kubitsa () n'ukubikura ()
y'umupangayi nimeru _____ biciye ku nimeru _____ ishami rya _____ mu
gisagara ca _____, Intara ya Ohio, igitigiri c'amahera angana n'ugupanga buri ukwezi kumwe, ukongera
ko ayandi mahera yishuzwa hakurikijwe amasezerano yo kwishura buri ukwezi;

2) Umupangayi yemereye kandi CMHA kugabanya amahera yiyongereye arihwa n'umupangayi,
harimwo ariko hatagumye ku, ay'umuyagankuba n'amazi, uturusho ku mahera adakwiye n'amahera yo
gusanura;

3) Amahera yo gupanga n'ayandi mahera asabwa, niba vyemewe, ategerezwa kurihwa umunsi wa
mbere wa buri ukwezi. CMHA itegerezwa gukura kuri konte yo kubitsa () n'ukubikura () y'umupangayi
kw'itariki canke hafi y'itariki _____ ya buri ukwezi aho amahera yo gupanga n'ayandi yiyongera
ategerezwa kurihwa. Amahera yose arenga kuyo CMHA irihisha aca asubizwa umupangayi;

4) CMHA nitegerezwa gutangura urubanza rwo kwirukana abatarishe amahera yo gupanga, hamwe
nayandi mahera yemewe mugihe umupangayi afise gutanga amahera kuri banki, kubandanya yishura kuri
banki kandi afise amahera akwiriye aboneka. Hamwe ibi bisabwa bitubahirijwe, CMHA irashobora
kwirukana umupangayi kuko atishuye amahera yo gupanga inzu. Ubundi kandi, konti idafise-amahera
akwiriye izotozwa amahera na NSF atozwa na banke yumupangayi hamwe na CMHA.

5) Umupangayi arumva yuko uruhusha rwa CMHA ruzokoresheya gushika amenyesheje **CMHA** na
banke yiwe mu nyandiko ko atagikeneye iki gikorwa, akabaha umwanya ukwiriye kugira ngo bakorere kuri

7) Kugabanya bunu nyene amahera yo gupanga, hamwe nayandi mahera, yemewe, bizotangura
kwitariki yo kwemeza ya mbere inyuma yo kuronka iki cemezo nuwuserukira DDARP nigisata
cuwakira Amakonte yabapangayi. Umupangayi ategerezwa kwama ariha amahera yo gupanga, ayandi mahera
arihwa, yemewe, mu gihe c, imfata-kibanza;
